

Effects of the Noto Peninsula Earthquake of 2024

We extend our deepest sympathy to all those impacted by the seismic events on the Noto Peninsula in Ishikawa Prefecture, Japan on January 1, 2024. We sincerely hope for the earliest possible restoration and recovery of all affected areas.

Hakusan, Japan, January 10, 2024 - EIZO Corporation (TSE: 6737) would like to communicate details regarding the impact of the earthquake on its headquarters and factory located in Hakusan City, Ishikawa Prefecture, as well as the factories of EIZO MS Corporation (a Group company situated in Hakui and Nanao, Ishikawa Prefecture).

1. Operation Status of Business Sites

(1) EIZO Corporation Headquarters and Factory

Operations have resumed normally since January 4. Additionally, as part of the recovery efforts, we relocated certain production lines from the Nanao Factory of EIZO MS Corporation to our factory in Hakusan city. We anticipate commencing production on these relocated lines shortly.

(2) EIZO MS Corporation (Hakui Factory)

Following thorough inspections and trial operations of our factory building and production facilities, we have verified that production can be safely resumed. Beginning January 10, we plan to gradually recommence operations with reduced hours. Our objective is to fully restore normal operations by the end of January.

(3) EIZO MS Corporation (Nanao Factory)

Repairs to the factory building are currently in progress, alongside ongoing inspections of production equipment. Concurrently, certain challenges persist in daily life infrastructure, including water outages and other factors. We are actively monitoring the restoration progress of these facilities. Our primary focus remains on prioritizing the well-being and safety of our employees. With the aim of resuming production activities, we are diligently working towards achieving this goal by the end of January.

2. Impact on Business Performance

We are currently assessing the overall impact on our business performance. Details of the impact will be disclosed in conjunction with the announcement of our financial results for the third quarter of the fiscal year ending March 31, 2024, scheduled for release on January 31, 2024.
