

Effects of the Noto Peninsula Earthquake of 2024 (Update)

We extend our deepest sympathy to all those impacted by the seismic events on the Noto Peninsula in Ishikawa Prefecture, Japan on January 1, 2024. We sincerely hope for the earliest possible restoration and recovery of all affected areas.

Hakusan, Japan, January 22, 2024 - EIZO Corporation (TSE: 6737) would like to update the information regarding the impact of the earthquake on its headquarters and factory located in Hakusan City, Ishikawa Prefecture, as well as the factories of EIZO MS Corporation (a Group company situated in Hakui and Nanao, Ishikawa Prefecture).

1. Operation Status of Business Sites

(1) EIZO Corporation Headquarters and Factory

Operations have resumed normally since January 4. Additionally, as part of the recovery efforts, we completed the relocation of certain production lines from the Nanao Factory of EIZO MS Corporation to our factory in Hakusan city as scheduled.

(2) EIZO MS Corporation (Hakui Factory)

We have been operating on a modified schedule since January 10, prioritizing the lives and safety of our dedicated workforce. Maintaining this consideration, we anticipate resuming 70% of normal operations from January 29 and full operations from February 13.

(3) EIZO MS Corporation (Nanao Factory)

Repairs of the factory building, along with inspections and trial operations of the production equipment have been successfully completed. Beginning January 22, we anticipate gradually recommencing 30% of operations with modified hours, and full operations from March 4. We are also mindful that certain challenges persist in infrastructure required in daily life, including water outages and other factors, and are actively monitoring the restoration progress of these facilities. Our primary concern remains prioritizing the well-being and safety of our employees.

2. Impact on Business Performance

We are currently assessing the overall impact on our business performance. Details of the impact will be disclosed in conjunction with the announcement of our financial results for the third quarter of the fiscal year ending March 31, 2024, scheduled for release on January 31, 2024.
