

- The specifications noted in this manual are only applicable when using the power cords provided together with the product and EIZO-specified signal cables.
- · Only use EIZO accessories products specified by EIZO with this product.

Precautions for Use

- Parts (such as the LCD panel and the fan) may deteriorate if used over extended periods of time. Periodically check that they are operating normally.
- When the screen image is changed after displaying the same image for extended periods of time, an afterimage may remain. Use the screensaver or power save function to avoid displaying the same image for extended periods of time. An afterimage may appear even after a short time period has elapsed depending on the displayed image. To remove such a phenomenon, change the image or keep the power turned off for several hours.
- It takes about 30 minutes for the monitor display to stabilize. Please wait 30 minutes or more after the monitor power has been turned on or the monitor has recovered from power saving mode before making adjustments to it.
- If the monitor displays continuously over a long period of time, smudges or burn-in may appear. To maximize the life of the monitor, we recommend the monitor be turned off periodically.
- The backlight of the LCD panel has a fixed lifetime. Depending on the usage pattern, such as usage for long continuous periods, the lifespan of the backlight may run out sooner, requiring replacement. When the screen becomes dark or begins to flicker, please contact your local EIZO representative.
- The screen may have defective pixels or a small number of light dots on the screen.
 This is due to the characteristics of the LCD panel itself, and is not a malfunction of the product.
- Do not scratch or press on the LCD panel with any sharp objects, at this may result in damage to the LCD panel. Do not attempt to brush with tissues as this may scratch the panel.
- Dew condensation may form on the surface or interior of this product when it is brought
 into a cold room, when the temperature suddenly rises, or when it is moved from a cold
 room to a warm room. In that case, do not turn the product on. Instead wait until the dew
 condensation disappears, otherwise it may cause some damage to the product.
- (Cautions for the Use of the Touch Panel)

Cleaning

1.1 Features


1.1.1 Full-Flat Design

A full-flat design with a flat bezel is adopted. You can properly touch right to the edge of the screen.



1.1.2 Easy-to-touch Stand Mechanism


The tilt angle can be adjusted steplessly. You can smoothly change the screen position to make it easier to work in a way that suits how you are using the monitor, such as for office work or multi-touch operations.




1.1.3 10-point Multi-touch Support

Multi-touch can be used to zoom in/out and rotate. The screen responds to light touches, so flick and drag operations can be performed with ease.




1.3.1 Front

2 Installation / Connection

2.1 Before installation

Carefully read PRECAUTIONS [▶ 3] and always follow the instructions.

If you place this product on a lacquer-coated desk, the color may adhere to the bottom of the stand due to the composition of the rubber. Check the desk surface before use.

2.1.1 Installation conditions


When installing the monitor in a rack, ensure that there is adequate space around the sides, back and top of the monitor.

Attention

· Position the monitor so that there is no light to interfere with the screen.

2.2 Installing

Place a soft cloth or similar material on a stable desk, and open the stand until it makes a clicking sound.



Attention

· Do not use the monitor while it is in its packaging. While packaged, the stand is closed, so there is a risk of the monitor falling over.

2.3 Connecting Cables

Attention


- · Check that the monitor, PC, and peripherals are powered off before connecting.
- When replacing the current monitor with this monitor, see 4.2 Compatible Resolutions [> 28] to change the PC settings for resolution and vertical scan frequency to those that are available for this monitor, before connecting the PC.

1. Connect signal cables.

Check the shapes of the connectors, and connect the cables. When connecting an HDMI cable, fasten the cable with the supplied cable tie. When connecting a D-Sub mini 15-pin cable, tighten the fasteners down to secure the connector.

Connect the USB cable when using the monitor as a touch panel monitor. Connecting it will enable the USB hub function.

The stereo mini jack cable is for when you want to get audio from the monitor speakers when the D-Sub mini 15-pin cable has been used for connection.




Attention

• When connecting to multiple PCs, switch the input signal. For details, refer to the Installation Manual (on the CD-ROM).

Note

• If the cables are difficult to insert, adjust the angle of the screen.

2. Plug the power cord into a power outlet and the power connector on the monitor. Insert the power cord fully into the monitor.



2.4 Turning On the Power

- 1. Check if the main power switch is on.
- 2. Press 1 to turn on the power to the monitor. The power switch indicator of the monitor lights up blue. If the indicator does not light up, see 3 No-Picture Problem [▶ 24].
- 3. Turn on the PC. The screen image appears. If an image does not appear, see 3 No-Picture Problem [> 24] for additional advice.

Attention


- Depending on the PC settings, the display may not show correctly, or not be at the appropriate scale. Check the settings for the PC if required.
- For the maximum power saving, it is recommended that the Power button be turned off. When not using the monitor, you can turn off the main power supply or disconnect the power plug so that the power is cut completely.

Note

- · In order to maximize the monitor's lifespan by impeding brightness degradation and to reduce power consumption, carry out the following:
 - Use the power saving function of the PC or monitor.
 - Turn off the monitor after using it.

2.5 Adjusting the Screen Angle

Hold the left and right edges of the monitor with both hands, and adjust the screen tilt to the optimum position for performing tasks.




Attention

· After the adjustment is finished, make sure that the cables are correctly connected.

2.6 Mounting the Touch Pen Holder


Mount the touch pen holder in either of the holes to the left and right on the rear side of the monitor. To mount the holder, use the touch pen holder mounting screw.



2.7 Touch Panel Setup

Connect the USB cable, and after completing installation, run the sensitivity adjustment software TPOffset.

TPOffset is included in the EIZO LCD Utility Disk (CD-ROM).



Note

- TPOffset can also be downloaded from our website. (www.eizoglobal.com)
- Run TPOffset as necessary in the following cases:
 - The usage environment has changed significantly
 - Operability feels changed
 - There is an issue with touch operations, such as the cursor position shifting or the cursor jumping

3 No-Picture Problem

Power switch indicator does not light up.

- · Check whether the power cord is connected properly.
- Turn the main power switch on.
- Press ().
- · Turn off the main power, and then turn it on again a few minutes later.

Power switch indicator lights up: Blue

• Increase "Brightness", "Contrast", or "Gain" in the Setting menu. For details, refer to the Installation Manual (on the CD-ROM).

Power switch indicator lights up: Orange

- Use → to switch the input signal.
- Turn the setting "On" for "Compatibility Mode" on the "Administrator Settings" menu. For details, refer to the Installation Manual (on the CD-ROM).
- · Move the mouse or press any key on the keyboard.
- · Touch the touch panel.
- · Check whether the PC is turned on.
- Turn off the main power, and then turn it on again.

Power switch indicator flashes: Orange

- This symptom may occur when the PC is connected to the DisplayPort connector. Use a signal cable recommended by us for the connection. Turn the monitor off and on.
- Check the connection and condition of the USB peripheral devices connected to the monitor.

The message "No Signal" appears on the screen.


Example:

DisplayPort No Signal

- The message shown above may appear as some PCs do not output the signal immediately after power-on.
- · Check whether the PC is turned on.
- Check whether the signal cable is connected properly. Connect the signal cables to the connectors of the corresponding input signal.
- Use
 to switch the input signal.
- Turn off the main power, and then turn it on again.
- Try setting "Auto Input Detection" in the "Administrator Settings" menu to "Off" and switching the input signal manually. For details, refer to the Installation Manual (on the CD-ROM).

The message "Signal Error" appears on the screen.

Example:



- Check whether the PC is configured to meet the resolution and vertical scan frequency requirements of the monitor (see 4.2 Compatible Resolutions [> 28]).
- · Reboot the PC.
- Select an appropriate setting using the graphics board's utility. Refer to the User's Manual of the graphics board for details.
